445th Legislative Session | April 5th, 2023 | Legislative Day 86



## **Greetings from Annapolis!**

It's official - we are in that last week of the 445th Legislative Session! It has been a whirlwind three months, with some heartbreak and many victories along the way. My bills have had a fantastic run this year, with 14 bills ready to pass.

Each bill sits at a different stage of the legislative process. One of my bills was just released from Rules committee on the House side - this means that it needed a special dispensation to be re-referred to a House committee for a hearing and voting. This is by no means the end for this bill, it just means we have to fight a bit harder for it than the others. All of my other bills have been heard in the House, and are either waiting in committee for a vote, or are on the House floor! We have 4 bills that are headed to the Governor's desk to be signed into law, which is the last stage in this process.

I have also been hard at work amending bills and discussing changes to help strengthen other legislator's bills. I am so pleased at the spirit of collaboration and the attention paid to the greater public good as we work together to improve the lives of Marylanders. Our incredible delegates have been hard at work presenting their bills in front of the Education, Energy, and the Environment Committee.

The budget has officially passed! The Maryland General Assembly officially approved the budget on Monday, April 3rd. This is especially good news, as it means that we will not need to extend session in order to finalize the plan for 2024.

I have from now until April 10th - Sine Die - to pass my bills, as this is when Legislative Session officially adjourns. Monday marks the official 90th, and last, day of Maryland General Assembly Session 2023.

We are hard at work on our Sine Die letter, so stay tuned for our end-of-session official update. We are also coordinating with the 43rd District Legislators to plan a townhall for all of you to have the opportunity to hear about and ask questions about the 2023 session.

## **April is Climate Justice Month!!**

I was honored to be ranked 3rd in Environmental Justice for legislators in Maryland with a score of 98.99% - and I will keep fighting for environmental justice this April and beyond.

## FDA Approves Naloxone as an over-the-counter drug

Naloxone, also known colloquially as "Narcan", is an opioid agonist that prevents overdoses. With the rise in deaths from Fentanyl use, this drug will be able to save lives of Marylanders and will relieve some of the burden from belleaugured first-responders who often run out Naloxone during shifts because of the number of overdoses. Maryland is 6th in the Nation in overdose deaths - with 2,800 deaths from drug overdoses last year.

### Maryland Legislators Stop Ohio Wastewater from Being Processed in Baltimore

My colleagues and I from Baltimore City and Baltimore County came together over the past 2 weeks to plan how to prevent wastewater from the Ohio train derailment disaster from being processed at the Back River Water Treatment Plant. As many of you are aware, the Back River Wastewater Treatment Plant has faced some difficulties in the past year, including an explosion several weeks ago that damaged centrifuges. While those damages are apparently being repaired, I still had doubts about the processing capacity of the plant. After extensive meetings with the Mayor's Office, the County Executives, and other concerned legislators, we decided that we could not take this water. The Mavor's office subsequently issued an order to stop the water from being processed in



Baltimore, effectively ending the potential disaster. I am working diligently with other legislators now to see what can be done to prevent Baltimore from becoming an avenue for crisis processing in the future.

## Trans Health Equity Act is Headed to Governor Wes Moore!!

I am so excited to announce that my bill, SB0460 has passed both the House and the Senate chambers and is officially headed to the Governor's desk! Governor Moore has promised to sign this legislation into law. I have worked on this legislation since 2021; taking up the mantel from those who came before me to fight for LGBTQIA+ rights.

What does SB0460 do? This bill addresses a critical gap in the healthcare of transgender Marylanders by ensuring that medically necessary gender-affirming procedures and services are covered by Medicaid. Gender-affirming care is medically necessary, as demonstrated by peer-reviewed research, and by physical and behavioral health care providers and advocacy organizations. We will be joining 26 states, 1 territory, and D.C. that have Medicaid policies that do not exclude health care related to gender transition for transgender people.

These services are federally reimbursable and cost only 0.005% of the MD Medicaid budget. Maryland will save costs from reduced long-term physical and mental health complications, such as a 84% reduction in suicide attempts. Reducing discrimination is a cost-saving measure; without gender-affirming care, transgender people are more likely to be "outed." Twenty-four percent of trans Marylanders are evicted or denied housing because they are transgender, and nationwide are 4 times more likely to be victims of violent crime.

I am honored to have been a part of this fight, and I would like to thank Delegate Ann Kaiser for co-sponsoring this bill in the House, and I would especially like to thank all of the brave and persistent advocates who have made this bill possible. Thank you all.

#### An Update on my Social Work Bills:

The social work licensure bills made it through the Senate and will hopefully be voted out of the House today. The bills look quite different from the original draft, so we wanted to provide an update on how the bills have evolved.

**SBo871** was heard in the Senate Finance Committee on March 10. In an effort to find a middle ground between the advocates and those in opposition, the moratorium on the exam requirement was removed from the bill. The amended bill now mandates a workgroup to develop recommendations for an equitable path to social work licensure, extends the Board of Social Work Examiners (BSWE) through July 2025, and stipulates that the BSWE must notify applicants of receipt of their application within 15 days. The bill was then sent over to the House Health and Government Operations Committee and heard on March 30. The HGO Committee further amended the bill to include interim reports and expand the workgroup (including representatives from the Deaf and Hard-of-Hearing community and the NAACP), making it much more diverse and representative. While we no longer have the moratorium, we are still proud of how far this bill has come and are eager for the bill to pass and for the workgroup to get started!

SBo872 was also heard in the Senate Finance Committee on March 10 and, upon the committee's recommendation, was merged with SBo145. The amended version of SB145 that left the Finance Committee had authorized the Board of Social Work Examiners to issue a conditional or temporary license to practice social work to an applicant who, except for passing an exam, has met the appropriate education and experience requirements for a license issued to practice. However, after the bill was heard in the Health and Government Operations Committee and heard on March 30, SB0145 was amended, and the language from SB0872 that included temporary licensure was struck out. SB0145 now only provides conditional licensing. We are disappointed in the decision to remove temporary licensure and stand with advocates ready for a solution that immediately mitigates harm caused by not being able to pass the ASWB exam.

## It's the Final Countdown...

With five calendar days until the end of the 2023 Legislative Session, 36 pieces of legislation have received final approval and are headed to the desk of Governor Moore for signing, revealing the amount of legislation about to move forward this week. 


## WHAT'S HAPPENING IN (E3)

#### **Energy**

EEE has spent quite a bit of time this session looking at utilities for Marylanders this session. We have gone over EmPOWER - the energy efficiency program, to see how we can improve and update it. We have also looked at the rising costs of energy, and how to lower energy bills and assist constituents unable to pay the new fees. We also wanted to look at utility shutoffs, and water and wastewater processing, and have had the opportunity to hear many bills and briefings addressing these topics.

#### **Education**

On the education front, my virtual education reform bill has moved to the House! We have also made sweeping improvements to the Blueprint for Maryland, including teacher recruitment incentives,
